Investigating wrongful convictions is a long process with a slow case turnover. The decision to take a case on is at the discretion of the project that you contact and it is advised that you only contact your local projects. If a project chooses not to review your case they will inform you, but they may add you to the database where another project may take your case on.



Law Commission Winning Report 2015 – “A meeting of minds: denouncing ‘parasitic liability’ in joint enterprise”

A meeting of minds: denouncing ‘parasitic liability’ in joint enterprise

This report will focus on the common law doctrine of joint enterprise and discuss how the current English legal system is in the state of a “dog’s breakfast”¹ because of this heinous law. It will describe how joint enterprise has become a specific weapon used by criminal justice system agents i.e. the police and the courts to target both “political protest and ‘gang’ violence”.² It will also explore social, legal and economic implications that have risen as a result of that process. The report will conclude by examining possible reforms, whom some consider are long overdue³, as well as potential outcomes these reforms could have on the legal system.
